Exactly what you get on the 5-day St. John Group Tour

- **Prices** – Prices are based on double occupancy. See [website for current prices](#).
- **Day 1** – Each couple transports itself to St. Thomas's Cyril King International Airport. We provide private transportation to and from the beautiful [Westin Resort](#) on St. John and one of their lovely private Studio Rooms with a king bed, resort view, and balcony for 5 nights.
- **Breakfasts** – No breakfasts are included in the price because while the Westin offers breakfast, it is not included in the booking.
- **Transportation & gear** – During the 5 full days of the tour, we provide transportation to and from all tour activities; snorkeling gear (mask, snorkel, fins) beach chairs, beach shade/umbrellas; expert instruction for snorkeling, paddleboarding, and kayaking; and light snacks, soft drinks, and water.
- **Day 2 – Maho Bay & more:** We transport you to Maho Bay where we provide kayaks, paddleboards, a guided paddleboard tour, a tasty picnic lunch, and a delicious pain-killer drink. On the drive back to the Westin, we take you to [the Windmill Bar](#) for its stunning 270 degree views and whatever food and drink you buy for yourself.



Exactly what you get (continued)

- **Day 3 – Salt Pond Bay & more:** We transport you with all your gear to Salt Pond Bay, lead a hike [on the Ram Head Trail](#), help you find the best snorkeling spots, and provide a tasty picnic lunch. On the way back to the Westin, we'll take you to one of our favorite local restaurants, [Johnny Lime](#), for an early dinner and drinks that you buy for yourself. That night you are free to explore on your own.
- **Day 4 – Trunk Bay & more:** We transport you with all your gear to and from Trunk Bay. There we will help you find the best snorkeling spots and provide a tasty picnic lunch. On the way back to the Westin, we'll take you to our favorite local restaurant, Johnny Lime, for an early dinner and drinks that you buy for yourself. That night you can join the group for dinner in Cruz Bay or explore on your own.
- **Day 5 – Haulover Bay & more:** We transport you with all your gear to Haulover Bay where Jennifer Russo of [Reef2Peak](#) will lead a fun, fascinating kayaking, snorkeling, and nature tour around Hurricane Hole. We'll transport you to [Skinny Legs](#) where you will buy your own tasty lunch. Next, we'll transport you to the [Annaberg Historic Sugar Plantation](#) where you can enjoy the stunning views, explore the ruins, relax by a beautiful creek setting, and/or hike along the water's edge of the [scenic Leinster Bay trail](#) to Waterlemon Cay where you can swim and snorkel. After Annaberg, we'll drive 4 minutes to the lovely Francis Bay beach, where we'll enjoy the beautiful sunset, the warm water, drinks, and a tasty light dinner. And, we'll see if I can convince Jennifer to lead us on a sunset nature walk. That night you can join the group for dinner in Cruz Bay or explore on your own.
- **Day 6 – Return to St. Thomas:** We use the Westin's private transportation to help you easily get back to the airport.

The meals included

- **Breakfast** – We didn't include breakfast because the Westin charges separately for it, some people don't like eating early, and we'll provide a cooler with light snacks, water, and soft drinks whenever we transport you from the Westin. This means you can take a light breakfast from the cooler every morning if needed.
- **Lunches** – We provide tasty picnic lunches on day 2 at Maho Bay and day 3 at Salt Pond Bay. On day 4 at Trunk Bay, because there are onsite food and drink vendors, we gave you the freedom to buy what you like. On day 5, we'll take you to [Skinny Legs](#) where you can buy your own lunch.
- **Dinners** – We provide a tasty picnic dinner on day 5 at Francis Bay. On day 3, we'll take you to one of our favorite local restaurant, [Johnny Lime](#), for an early dinner and drinks that you buy for yourself. We decided not to include other dinners in the price so you can have the freedom to decide what to eat, where, how much to eat, and how much to spend.
- **Lights snacks & drinks** – Any time we transport you from the Westin, we will always have a cooler with light snacks, soft drinks, and water for you.



Payment and cancellation terms

- **Conditionally refundable \$500 deposit:** Each couple pays a \$500 conditionally refundable deposit upon booking. If the couple cancels any time after booking and paying the deposit, the deposit is non-refundable. But, if the tour is cancelled for any reason by the tour company, it will refund the \$500 deposit within 30 days of cancellation.
- **Payments and other refunds:** Upon booking, each couple shall pay the full amount of the trip by check. These payments are subject to the following conditions:
 - If the couple cancels its reservation 90 days or more before the tour's start date, it shall receive a full refund minus the \$500 deposit;
 - If the couple cancels its reservation less than 90 days before the tour's start date but at least 60 days before the tour's start date, it shall receive a refund of 75% of its payment;
 - If the couple cancels its reservation less than 60 days before the tour's start date but at least 30 days before the tour's start date, it shall receive a refund of 50% of its payment;
 - If the couple does not cancel its reservation at least 30 days before the tour's start date, the couple shall not under any circumstances receive any refund and shall forfeit all rights to collect any of its payment. But, it shall have the right to use the accommodations; and
- **Cancellation by the tour company:** If the tour company cancels the trip for any reason, the following rules apply:
 - The tour company shall provide a full refund within 30 days of cancellation;
 - The tour company shall not be liable under any circumstances for anything under any theory of liability and/or cause of action;
 - Upon cancellation, the tour company is only obligated and/or liable to provide a full refund within 30 days of cancellation as defined by the terms set-forth in this document.
- **How to cancel reservations:** To officially cancel a reservation, guests must both (1) email the tour company's owner Elliot Turrini at Elliot.Turrini@Gmail and (2) send him a text at 201 572-4957.
- **The vital importance of trip insurance:** Because inclement weather and/or insufficient interest in a tour may cause the tour company to cancel a tour, it is vital that all guests booking one of our tours should purchase trip insurance that covers any of the guest's costs related to the tour such as but not limited to airfare.
